An Act To Allow Learner's Permits To Be Issued by Driver Education Schools

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 29-A MRSA §1304, sub-§1-A,** as amended by PL 2015, c. 114, §1, is
3 further amended to read:

4 **1-A. Learner's permit; issuance.** The following provisions apply to the issuance of
5 a learner's permit.

6 A. Fees for a learner's permit may be collected ~~only~~ by the Secretary of State in
7 accordance with section 154, subsection 1 or by the provider of a driver education
8 course under section 1351, which shall deposit the fees with the Secretary of State.

9 B. Any required application materials for a learner's permit may be collected ~~only~~ by
10 the Secretary of State or by the provider of a driver education course under section
11 1351, which shall forward the materials to the Secretary of State.

12 C. Any required examination for a learner's permit may be administered only by the
13 Secretary of State except that the Secretary of State may waive this requirement on
14 receipt of a course completion certificate under section 1351, subsection 3.

15 D. A learner's permit may be issued only by the Secretary of State- except that the
16 provider of a driver education course may issue a learner's permit forwarded by the
17 Secretary of State after the Secretary of State has received:

18 (1) Fees pursuant to paragraph A;

19 (2) Application materials pursuant to paragraph B; and

20 (3) A course completion certificate pursuant to paragraph C.

21 **SUMMARY**

22 This bill allows the provider of a driver education course to collect fees and
23 application materials for a learner's permit and to issue a learner's permit to a person
24 following receipt by the Secretary of State of the fees, the application materials and a
25 course completion certificate.
