A hunting license of a person convicted of shooting from any public paved way during the open firearm season on deer pursuant to section 11208, subsection 1, paragraph A-1 must be revoked, and that person is ineligible to obtain a hunting license for a period of one year from the date of conviction. |

| 24 25 26 27 28 29 30 | This bill makes shooting during the open firearm season on deer, which includes the special muzzle-loading open season on deer, at any wild animal or wild bird with a firearm having a rifled barrel from any public paved way or from within 100 feet from the center of the pavement of the public paved way or from within the right-of-way of any controlled access highway a Class E crime for which a fine of \$500 must be adjudged. It also provides for the one-year suspension of the hunting license of a person convicted of doing so. |
