## An Act To Improve the Foreclosure Process by Regulating Mortgage Loan Servicers

#### 1 Be it enacted by the People of the State of Maine as follows:

**Sec. 1.** 9-A MRSA §1-301, sub-§17, as repealed and replaced by PL 2011, c. 427, Pt. A, §4, is amended to read:

4 **17.** "Creditor" means a person who both:

5 A. Regularly extends, whether in connection with loans, sales of property or 6 services, or otherwise, consumer credit that is payable by agreement in more than 4 7 installments or for which the payment of a finance charge is or may be required; and

8 B. Is the person to whom the debt arising from the consumer credit transaction is 9 initially payable on the face of the evidence of indebtedness or, if there is no such 10 evidence of indebtedness, by agreement; except that, in the case of an open-end credit 11 plan involving a credit card, the card issuer and any person who honors the credit 12 card and offers a discount that is a finance charge are creditors.

13 For the purpose of the requirements imposed under Article 8-A for credit billing pursuant to 15 United States Code, Section 1666 et seq. and for open-end consumer credit pursuant 14 15 to 15 United States Code, Section 1637(a)(5), (a)(6), (a)(7), (b)(1), (b)(2), (b)(3), (b)(8)16 and (b)(10), "creditor" also includes card issuers whether or not the amount due is 17 payable by agreement in more than 4 installments or the payment of a finance charge is or may be required and the administrator shall by regulation apply these requirements to 18 19 those card issuers, to the extent appropriate, even though the requirements are by their 20 terms applicable only to creditors offering open-end credit plans.

For the purposes of this Title, "creditor" also includes any person who originates 2 or more mortgages referred to as high-cost mortgage loans under Article 8-A, section 8-506 in any 12-month period or any person who originates one or more such mortgage loans through a mortgage broker as defined in Article 8-A, section 8-506, subsection 1, paragraph J, or a loan broker as defined in Article 10.

For purposes of this Title, "creditor" also includes a private educational lender as that term is defined in 15 United States Code, Section 1650.

A person regularly extends consumer credit only if the person extended credit other than credit subject to high-cost mortgage loan requirements more than 25 times or more than 5 times for transactions secured by a dwelling in the preceding calendar year. If a person did not meet these numerical standards in the preceding calendar year, the numerical standards must be applied to the current calendar year.

32 33 34 35 36	1. The administrator shall receive and act on all applications for licenses to make <u>or</u> <u>service</u> supervised loans under this Act. Applications must be filed in the manner prescribed by the administrator and must contain the information required by the administrator to make an evaluation of the financial responsibility, character and fitness of the applicant.

1 A. For a lender subject to this subsection whose activities include making or 2 arranging residential mortgage loans, an application for a license to make or service supervised loans must be made electronically, through the nationwide mortgage 3 licensing system and registry. Licenses expire December 31st of each year and must 4 5 be renewed through the nationwide mortgage licensing system and registry. An 6 application for an initial license must be accompanied by a fee of \$250, and an annual 7 renewal application must be accompanied by a fee of \$100. An application for an initial license or renewal for a place of business other than that of the applicant's first 8 9 licensed location must be accompanied by a fee of \$100. An applicant must also pay 10 a nationwide mortgage licensing system and registry processing fee in an amount to be determined by the administrators of the nationwide mortgage licensing system and 11 registry. A nonprofit organization exempt from taxation under the United States 12 Internal Revenue Code, Section 501(c)(3) and engaged in the financing of housing 13 14 for low-income people under a program designed specifically for that purpose must pay an initial licensing fee, and a fee for each branch location, of \$20 and a renewal 15 licensing fee and renewal fee for each branch location of \$10, plus the applicable 16 17 nationwide mortgage licensing system and registry processing fee.

B. For a lender subject to this subsection whose activities do not include making or arranging residential mortgage loans, an initial application for a license must be accompanied by a \$500 fee and a renewal application must include a \$200 fee. A license is granted for a 2-year period and expires on September 30th of the 2nd year. An application for an initial license or renewal for a place of business other than that of the applicant's first licensed location must be accompanied by a fee of \$200.

24 2. A license to make or service supervised loans or as a mortgage loan originator 25 may not be issued unless the administrator, upon investigation, finds that the financial responsibility, character and fitness of the applicant, and of the members thereof, if the 26 applicant is a copartnership or association, and of the officers and directors thereof, if the 27 applicant is a corporation, and, when applicable, the character and fitness of the mortgage 28 loan originators thereof, are such as to warrant belief that the business will be operated 29 30 honestly and fairly within the purposes of this Act. In determining the financial 31 responsibility of an applicant proposing to engage in making insurance premium loans, 32 the administrator shall consider the liabilities the lender may incur for erroneous 33 cancellation of insurance.

34 A. Every applicant shall also, at the time of filing such application, file with the 35 administrator, if the administrator so requires, a surety bond satisfactory to the 36 administrator in an amount not to exceed \$50,000. The terms of the bond must run 37 concurrent with the period of time during which the license will be in effect. The bond must run to the State for the use of the State and of any person or persons who 38 may have a cause of action against the licensee under this Act. The bond must be 39 40 conditional that the licensee will faithfully conform to and abide by the provisions of this Act and to all rules lawfully made by the administrator under this Act and will 41 pay to the State and to any such person or persons any and all amounts of money that 42 may become due or owing to the State or to such person or persons from the licensee 43 44 under and by virtue of this Act during the period for which the bond is given.

B. As used in this section, the term "financial responsibility" means that the applicant has available for the operation of the licensed business net assets of at least \$25,000 and upon issuance of a license, each licensee shall maintain net assets of at least \$25,000 that are either used or readily available for use in the conduct of the business of each office of the licensee in which supervised loans are made <u>or serviced</u>.

6 D. In determining the financial responsibility of a nonprofit organization engaged in 7 the financing of housing for low-income people under a program specifically 8 designed for that purpose, the administrator may waive the requirement of a bond and 9 availability of \$25,000 of net assets, if the applicant submits appropriate additional 10 evidence of financial responsibility.

3. Upon written request, the applicant is entitled to a hearing on the question of the 11 12 applicant's qualifications for a license or registration if (a) the administrator has notified the applicant in writing that the application has been denied, or (b) the administrator has 13 14 not issued a license or registration within 60 days after the application for the license or 15 registration was filed. A request for a hearing may not be made more than 15 days after the administrator has mailed a writing to the applicant notifying the applicant that the 16 17 application has been denied and stating in substance the administrator's findings 18 supporting denial of the application.

4. A separate license is required for each place of business. Each branch location
license application must be accompanied by a surety bond, in a form acceptable to the
administrator, in the amount of \$50,000.

5. A licensee may conduct the business of making <u>or servicing</u> supervised loans only at or from any place of business for which <u>he the licensee</u> holds a license and not under any other name than that in the license. For purposes of this subsection, the closing of a supervised loan, secured by an interest in real estate, made by the licensee, at the office of an attorney or land title company, <u>shall may</u> not be considered the making <u>or servicing</u> of a supervised loan at the place of business other than the licensee's licensed location. Loans made pursuant to a lender credit card do not violate this subsection.

5-A. A licensee subject to subsection 1, paragraph A may conduct the business of
 making supervised loans only through a mortgage loan originator who possesses a
 current, valid license.

6. Any supervised loan, otherwise valid under the provisions of this Act, made by any corporation or by any subsidiary or affiliate of any corporation to which a license is granted by the administrator on or before June 30, 1975, and to which said supervised loan is assigned, shall be is deemed to have been made by a duly licensed licensee, provided the administrator finds that said corporation has made a good faith effort to comply with the licensing provisions of this Act.

1. The administrator may file a complaint with the District Court to suspend or revoke a license to make or, originate or service supervised loans if the administrator finds reason to believe, after investigation or hearing, or both, that:

- 1 A. The licensee has violated this Act or any rule or order made pursuant to this Act; 2 or
- B. Facts or conditions exist that would clearly have justified the administrator in refusing to grant a license had these facts or conditions been known to exist at the time the application for the license was made.

Notwithstanding Title 5, sections 10003 and 10004 and Title 10, section 8003, if the 11 public interest or the protection of borrowers so requires, the administrator may, by order, 12 suspend a license to make or service supervised loans or a license as a mortgage loan 13 14 originator or postpone the effective date of such a license. Upon entry of the order, the administrator shall promptly notify the applicant or licensee that an order has been 15 entered, of the reasons for the order and that, within 15 days after the receipt of a written 16 17 request by the applicant or licensee, the matter must be scheduled for hearing. Section 2-303 applies to all subsequent proceedings. 18

The administrator may direct each licensee to file composite annual and quarterly 22 reports relating to all supervised loans made or, arranged or serviced by that licensee. 23 Information contained in annual and quarterly reports is confidential and may be 24 published only in composite form. The administrator may at any time require additional 25 reports if the administrator determines such action necessary to the proper supervision of 26 licensees.

29 §2-309. No other business for purpose of evasion

30 A supervised lender may not carry on other business for the purpose of evasion or 31 violation of this Act at a location where he the supervised lender makes or services 32 supervised loans.

- This bill amends the Maine Consumer Credit Code to add mortgage loan servicer to the definition of "creditor," to define "mortgage loan servicer" and to require mortgage loan servicers to be licensed in the same manner as supervised lenders are.
