14	Amend the bill by striking out all of section 5 and inserting the following:
15 16	'Sec. 5. 5 MRSA §15303, sub-§7, as enacted by PL 1999, c. 401, Pt. AAA, §3, is amended to read:
17 18 19	7. Other duties and powers. The institute shall do all things necessary or convenient to carry out the lawful purposes of the institute under this chapter, and may establish and operate programs, including, but not limited to, the following:
