14	§1125. Exemption from criminal liability for person who seeks medical assistance
15 16 17 18 19 20 21	A person who experiences a drug overdose and is in need of medical assistance or a person acting in good faith who seeks medical assistance for another experiencing a drug overdose may not be arrested, prosecuted or held in detention under section 1107-A, 1108, 1111 or 1111-A or chapter 49 if the grounds for the arrest, prosecution or detention arose from the person's seeking medical assistance for the drug overdose. For the purposes of this section, "detention" has the same meaning as in Title 15, section 3003, subsection 4-B.'

27 28	Amend the bill in section 5 in subsection 4 by striking out all of the blocked paragraph (page 2, lines 10 to 12 in L.D.) and inserting a new blocked paragraph to read:

32	Amend the hill by striking out all of section 8 and inserting the following:

This amendment is the minority report of the committee. It removes the provisions in the bill that decriminalize possession of a hypodermic apparatus. It returns to the Department of Health and Human Services rule-making authority over establishing community-based drug overdose prevention programs, which is removed in the bill. It directs the department to provisionally adopt rules regarding community-based drug overdose prevention programs by January 15, 2018. It removes from the bill the appropriation for syringe exchange programs and naloxone hydrochloride distribution.
