A, §5, is 12 13 further amended to read: 14 2. Application after 5 years. A person subject to the provisions of subsection 1, 15 paragraph A-1 or C as a result of a conviction or adjudication may, after the expiration of 5 years from the date that the person is finally discharged from the sentences imposed as 16 17 a result of the conviction or adjudication, apply to the commissioner before January 1, 18 2018 for a permit to carry a firearm subject to subsection 4. A person subject to the 19 provisions of subsection 1, paragraph A-1, subparagraphs (1) to (4) or paragraph C as a 20 result of a conviction or adjudication may, after the expiration of 5 years from the date that the person is finally discharged from the sentences imposed as a result of the 21 22 conviction or adjudication, apply to the commissioner on or after January 1, 2018 for a 23 permit to carry a firearm subject to subsection 4. That person may not be issued a permit 24 to carry a concealed handgun pursuant to Title 25, chapter 252. A permit issued pursuant 25 to this subsection is valid for 4 years from the date of issue unless sooner revoked for cause by the commissioner. For purposes of this subsection, "firearm" does not include a 26 27 firearm defined under 18 United States Code, Section 921(3)." 28 SUMMARY 29 This amendment establishes that on or after January 1, 2018 the Commissioner of 30 Public Safety may no longer authorize a person to carry a firearm if that person was 31 convicted of certain crimes involving the use of a firearm against a person or the use of 32 any other dangerous weapon. 33 FISCAL NOTE REQUIRED 34 (See attached)
