1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §1507, sub-§5-A**, as amended by PL 2003, c. 20, Pt. OO, §2 and  
3 affected by §4 and amended by c. 114, §1, is further amended to read:

4 **5-A. Job development training.** The Governor may allocate funds from such  
5 account in amounts not to exceed in total the sum of \$1,000,000 to provide funds for any  
6 unusual, unforeseen or extraordinary needs for state assistance in creating jobs by  
7 assisting in meeting the training requirements of labor-intensive new or expanding  
8 industries. Allocations for this purpose may be made from this fund by the Governor  
9 only upon the written request of the Commissioner of Labor and the Commissioner of  
10 Economic and Community Development and after consultation with the State Budget  
11 Officer. The commissioners' request to the Governor must be formulated subsequent to  
12 their consultation with the Commissioner of Education, the President of the Maine  
13 Community College System and the director of the appropriate local workforce  
14 investment area designated pursuant to the federal Workforce ~~Investment~~ Innovation and  
15 Opportunity Act of 1998, Public Law ~~105-220~~ 113-128.

11 **Sec. 35. Maine Revised Statutes headnote amended; revision clause.** In  
12 the Maine Revised Statutes, Title 26, chapter 35, in the chapter headnote, the words  
13 "federal workforce investment act of 1998" are amended to read "federal workforce  
14 innovation and opportunity act" and the Revisor of Statutes shall implement this revision  
15 when updating, publishing or republishing the statutes.

## 16 SUMMARY

17 This bill replaces all references to the federal Workforce Investment Act of 1998 with  
18 the federal reauthorization of that act, the Workforce Innovation and Opportunity Act,  
19 and changes the name of the State Workforce Investment Board to the State Workforce  
20 Board. The bill updates the duties and responsibilities of the State Workforce Board to  
21 conform to those articulated in the Workforce Innovation and Opportunity Act. It  
22 changes the reporting requirements to the Legislature to ensure the Legislature receives  
23 the same outcome measurements and expenditure information as is reported to the  
24 Federal Government under the Workforce Innovation and Opportunity Act. Finally, it  
25 requires the Center for Workforce Research and Information within the Department of  
26 Labor to publish annually a list of high-priority occupations that meet certain specified  
27 criteria, which is the same process used to create the list of high-wage, in-demand jobs  
28 produced by the Center for Workforce Research and Information and used by the  
29 Competitive Skills Scholarship Program.
