COMMITTEE AMENDMENT "B" to S.P. 549, L.D. 1567, Bill, "An Act To Amend the Archives and Records Management Law"

Amend the bill in section 3 by striking out all of subsection 4 (page 1, lines 17 to 21 in L.D.) and inserting the following:

**4. State agency or agency.** "State agency" or "agency" means any unit of State Government or local government, including any state board or commission, ~~except the Legislature and its committees and subcommittees, and the Judicial Department judicial branch,~~ but not including the University of Maine System, the Maine Community College System and the Maine Maritime Academy.'

Amend the bill in section 12 in §96 in subsection 2 in the 4th line (page 6, line 20 in L.D.) by striking out the following: "Secretary of State" and inserting the following: 'Governor'

Amend the bill in section 12 in §96 in subsection 2 in paragraph E in the first 2 lines (page 6, lines 29 and 30 in L.D.) by striking out the following: ", recommended by the Governor"

Amend the bill in section 12 in §96 in subsection 2 in paragraph F in the last line (page 6, line 32 in L.D.) by striking out the following: ", recommended by the Governor"

Amend the bill in section 12 in §96 in subsection 2 in paragraph G in the 3rd and 4th lines (page 6, lines 35 and 36 in L.D.) by striking out the following: ", recommended by the Governor"

Amend the bill in section 12 in §96 in subsection 3 in the 3rd line (page 7, line 1 in L.D.) by striking out the following: "Secretary of State" and inserting the following: 'Governor'

**SUMMARY**

This amendment is the minority report of the committee. This amendment removes the University of Maine System, the Maine Community College System and the Maine

**COMMITTEE AMENDMENT**

- 1 Maritime Academy from the definition of "state agency" proposed in the bill. This
- 2 amendment also changes the appointing authority for the Archives Advisory Board to the
- 3 Governor, rather than the Secretary of State as proposed in the bill.
