An applicant requesting the expedited issuance of a nondriver identification card under this section must pay an additional fee of \$10 and provide the reason for the request. The Secretary of State shall determine if expedited issuance is warranted.' |

| 21 22 23 24 | This amendment strikes the provision in the bill that reduces most violations of the International Fuel Tax Agreement laws from a Class E crime to a traffic infraction. The amendment also strikes the requirement that a vehicle offered for sale by a motor vehicle dealer must be accompanied by a valid certificate of title. |
| 25 26 27 28 | The bill creates an additional fee for expediting the issuance of driver's licenses and for expediting duplicates of driver's licenses and nondriver identification cards. The amendment also creates an additional fee for expediting the issuance of nondriver identification cards. |

Fiscal Detail and Notes

The bill establishes a \$10 fee for the expedited issuance of a duplicate driver's license and nondriver identification card and would result in an increase in Highway Fund revenue of \$112,500 in fiscal year 2017-18 and \$150,000 in fiscal year 2018-19. This analysis is based upon the average number of duplicate driver's licenses and nondriver identification cards issued over the last three years.
