1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 8 MRSA §1001, sub-§§1-A and 1-B**, as enacted by PL 2015, c. 499, §1,  
3 are repealed.

4 **Sec. 2. 8 MRSA §1001, sub-§29-C**, as enacted by PL 2015, c. 499, §2, is  
5 repealed.

6 **Sec. 3. 8 MRSA §1003, sub-§1, ¶J**, as amended by PL 2015, c. 499, §3, is  
7 further amended to read:

8 J. Negotiate consent agreements to resolve administrative violations or  
9 investigations; and

10 **Sec. 4. 8 MRSA §1003, sub-§1, ¶K**, as amended by PL 2015, c. 499, §4, is  
11 further amended to read:

12 K. Ensure that public safety inspectors employed by the board assigned to enforce  
13 the provisions of this chapter at the site of a casino may, in the absence of a sworn  
14 law enforcement officer, detain any person who is suspected of violating any  
15 provision of this chapter. Such detention must comply with federal and state laws  
16 including the provisions of Title 17-A, section 107; and

18 repealed.

19 **Sec. 6. 8 MRSA §1003, sub-§2, ¶¶S and T**, as amended by PL 2015, c. 499, §6,

21 S. Prepare and submit to the department a budget for the administration of this  
22 chapter; and

23 T. Keep accurate and complete records of its proceedings and certify the records as  
24 may be appropriate; and

25 **Sec. 7. 8 MRSA §1003, sub-§2, ¶U**, as enacted by PL 2015, c. 499, §7, is  
26 repealed.

27 **Sec. 8. 8 MRSA c. 31, sub-c. 7**, as amended, is repealed.

29 This bill repeals the laws permitting the practice of advance deposit wagering.
