It retains the section that authorizes 20 the Director of the Bureau of Parks and Lands within the Department of Agriculture, 21 Conservation and Forestry to grant an access easement to the Town of Fort Kent across 22 the Fort Kent State Historic Site to allow for strengthening and heightening of the earthen 23 flood barrier along the St. John River and protect the Fort Kent Blockhouse, a National 24 Historic Landmark, from flooding.
