1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 29-A MRSA §2093** is enacted to read:

3 **§2093. Municipal pilot programs for autonomous vehicles for public transportation**

4 Until March 31, 2022, a municipality may enter into a memorandum of agreement  
5 with the Secretary of State, the department and the Department of Professional and  
6 Financial Regulation, Bureau of Insurance pursuant to which the municipality may  
7 develop, test and operate a pilot program for the use of autonomous vehicles for public  
8 transportation in the municipality. For the purposes of this section, "autonomous vehicle"  
9 means a vehicle that is equipped with an automated driving system, designed to function  
10 without an operator. By December 1, 2021, a municipality that develops, tests or  
11 operates a pilot program pursuant to this section shall submit a report regarding the pilot  
12 program to the joint standing committee of the Legislature having jurisdiction over  
13 transportation matters. The joint standing committee may report out a bill relating to  
14 municipal programs for autonomous vehicles for public transportation to the Second  
15 Regular Session of the 130th Legislature.

16 **SUMMARY**

17 This bill authorizes municipalities to enter into memoranda of agreement with the  
18 Secretary of State, the Department of Transportation and the Department of Professional  
19 and Financial Regulation, Bureau of Insurance to develop, test and operate pilot programs  
20 for the use of autonomous vehicles for public transportation until March 31, 2022. It  
21 requires any municipality that develops, tests or operates a pilot program to submit a  
22 report regarding the pilot program to the joint standing committee of the Legislature  
23 having jurisdiction over transportation matters by December 1, 2021, and it authorizes the  
24 joint standing committee to report out a bill to the Second Regular Session of the 130th  
25 Legislature.
