SENATE AMENDMENT "A" to H.P. 1277, L.D. 1835, Bill, "An Act To Transfer Funds within the Department of Inland Fisheries and Wildlife"

Amend the bill in section 1 in the 2nd line (page 1, line 13 in L.D.) by striking out the following: "\$600,000" and inserting the following: '\$300,000'

Amend the bill in section 1 in the 4th and 5th lines (page 1, lines 15 and 16 in L.D.) by striking out the following: "License and Registration" and inserting the following: 'Warden Service'

Amend the bill by adding after section 1 the following:

Sec. 2. Transfer; Inland Fisheries and Wildlife carrying account. Notwithstanding any other provision of law, the State Controller shall transfer \$300,000 by June 30, 2019 from the Inland Fisheries and Wildlife carrying account, General Fund account within the Department of Inland Fisheries and Wildlife to the Warden Service General Fund account within the Department of Inland Fisheries and Wildlife. These funds may be allotted by financial order upon recommendation of the State Budget Officer and approval of the Governor.'

SUMMARY

This amendment alters the single transfer of \$600,000 by June 30, 2018 in the bill to 2 transfers of \$300,000, one occurring by June 30, 2018 and one occurring by June 30, 2019, and directs the money to the Warden Service General Fund account within the Department of Inland Fisheries and Wildlife instead of to the License and Registration General Fund account.

Fiscal Detail and Notes

This amendment reduces the one-time transfer in the bill of \$600,000 in fiscal year 2017-18 to \$300,000 in fiscal year 2017-18 and adds an additional transfer of \$300,000 in fiscal year 2018-19 from the Department of Inland Fisheries and Wildlife (IFW) General Fund carrying account and changes the recipient account to the IFW Warden Service General Fund account. The recipient account in the bill had been the IFW Licensing and Registration General Fund account. The transfers will fund a personal services shortfall in fiscal year 2017-18 that occurred because the savings anticipated through attrition did not materialize and for additional financial obligations as a result of changes to collective bargaining agreements.
