**SUMMARY**

This amendment is the minority report of the committee. It removes from the bill the elimination of the following boards and commissions: the Advisory Board for the Licensing of Whitewater Guides, the Advisory Committee on Fair Competition with Private Enterprise, the Maine Agricultural Water Management Board, the Tobacco Prevention and Control Advisory Council, the Board of Trustees of the Maine School for Marine Science, Technology, Transportation and Engineering and the St. Croix International Waterway Commission. The amendment also adds an appropriations and allocations section.

#### Fiscal Detail and Notes

This bill includes a deappropriation of \$2,500 in 2018-19 for the Legislature as a result of the elimination of the State Education and Employment Outcomes Task Force.

The bill also includes Other Special Revenue Funds deallocations of \$2,300 per year beginning in fiscal year 2018-19 to the Licensing and Enforcement program within the Department of Professional and Financial Regulation due to the Board of Licensing of Dietetic Practice being eliminated. The reduction in dedicated revenue from licensing and other fees is estimated to be \$70,991 annually beginning in fiscal year 2018-19.
