1           **Emergency preamble. Whereas,** acts and resolves of the Legislature do not  
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3           **Whereas,** the Department of Public Safety has proposed a management-initiated  
4 reorganization of the State Bureau of Identification; and

5           **Whereas,** the Department of Administrative and Financial Services, Bureau of  
6 Human Resources has reviewed the proposal and authorized the position reclassifications  
7 required to support the reorganization plan; and

8           **Whereas,** the reorganization cannot be implemented until funding is secured; and

9           **Whereas,** the effective and efficient functioning of the State Bureau of  
10 Identification is immediately necessary to its role of supporting law enforcement agencies  
11 throughout this State; and

12           **Whereas,** in the judgment of the Legislature, these facts create an emergency within  
13 the meaning of the Constitution of Maine and require the following legislation as  
14 immediately necessary for the preservation of the public peace, health and safety; now,  
15 therefore,

16           **Be it enacted by the People of the State of Maine as follows:**

17           **Sec. 1. Appropriations and allocations.** The following appropriations and  
18 allocations are made.
