1           **Emergency preamble. Whereas,** acts and resolves of the Legislature do not  
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3           **Whereas,** the 90-day period may not terminate until after the beginning of the next  
4 fiscal year; and

5           **Whereas,** the positions in this legislation are established as of the beginning of the  
6 next fiscal year, July 1, 2018; and

7           **Whereas,** in the judgment of the Legislature, these facts create an emergency within  
8 the meaning of the Constitution of Maine and require the following legislation as  
9 immediately necessary for the preservation of the public peace, health and safety; now,  
10 therefore,

11 **Be it enacted by the People of the State of Maine as follows:**

12           **Sec. 1. Appropriations and allocations.** The following appropriations and  
13 allocations are made.

**Sec. 2. Approval of the Attorney General not required.** Notwithstanding the Maine Revised Statutes, Title 5, section 191, subsection 3, paragraph B, written approval of the Attorney General is not required for the employment of persons under section 1.

**Emergency clause.** In view of the emergency cited in the preamble, this legislation takes effect when approved.

**SUMMARY**

This bill establishes 8 positions in the Department of Health and Human Services to replace positions that were eliminated by Public Law 2017, chapter 284, Part ZZZZZZ, section 9.
