9 COMMITTEE AMENDMENT "A" to H.P. 103, L.D. 121, Bill, "An Act To 10 Require the Department of Inland Fisheries and Wildlife To Implement a Firearm Safety 11 and Firearm Violence Prevention Program"

Amend the bill by striking out the title and substituting the following:

'An Act To Require the Department of Inland Fisheries and Wildlife To Promote
Safety with Respect to the Handling or Use of Firearms, Watercraft, All-terrain
Vehicles and Snowmobiles and in Other Outdoor Activities'

16 Amend the bill by striking out everything after the enacting clause and inserting the 17 following:

'Sec. 1. 12 MRSA §10056, as affected by PL 2003, c. 614, §9 and amended by c.
 655, Pt. B, §17 and affected by §422, is further amended to read:

#### 20 §10056. Division of Public Information and Education

The Division of Public Information and Education is established within the 21 22 Department of Inland Fisheries and Wildlife and is responsible for the administration of 23 programs to increase the public's knowledge and understanding of inland fisheries and wildlife resources and the management of these resources, including the administration of 24 25 education programs for hunter safety and for the safe operation of snowmobiles. watercraft and all-terrain vehicles. The division's responsibilities include public 26 27 education, promotion of inland fisheries and wildlife resources and the dissemination of information. The division's responsibilities also include conducting annual campaigns 28 29 promoting safety in the handling and use of firearms, watercraft, all-terrain vehicles and snowmobiles as well as campaigns promoting safety with respect to other outdoor 30 activities to the extent the division determines doing so would help improve safety in the 31 32 woodlands and inland waters of the State. Campaigns to promote safety must be 33 designed to reach target audiences effectively through television, radio, Internet or other communication mediums.' 34

2 This amendment replaces the bill and changes the title. The amendment requires the Department of Inland Fisheries and Wildlife, Division of Public Information and 3 4 Education to annually undertake campaigns to promote safety in the handling and use of firearms, watercraft, all-terrain vehicles and snowmobiles. The division is also directed 5 to promote safety with respect to other outdoor activities to the extent the division 6 7 determines such campaigns would help improve safety. The campaigns must be designed to reach the target audiences effectively through television, radio, Internet or other 8 communication mediums. 9
