Amend the amendment by striking out all of sections 3 and 4.

SUMMARY

16

This amendment eliminates the provision in Committee Amendment "A" that
17 requires that funds be provided to entities to establish new collaborative workspaces. It
18 also removes the language that directs the Department of Economic and Community
19 Development to prioritize development of new workspaces in the competitive application
20 process and to engage in at least 2 rounds of competitive applications. The amendment
21 also removes the one-time General Fund appropriation.

Fiscal Detail and Notes

This amendment removes the requirement that funds be provided to entities to establish new collaborative workspaces and eliminates the one-time General Fund appropriation in the bill of \$300,000 in fiscal year 2019-20. As amended, additional costs to the Department of Economic and Community Development to implement the requirements of this legislation can be absorbed within existing budgeted resources.
