15 16 17	Amend the bill in section 1 in §2112-B in subsection 2 in paragraph C in the first line (page 1, line 19 in L.D.) by striking out the following: " <u>Places</u> " and inserting the following: ' <u>Possesses</u> '
18 19 20	Amend the bill in section 1 in §2112-B in subsection 3 in paragraph B in the 3rd line (page 1, line 27 in L.D.) by inserting after the following: "camper" the following: 'while the motor home, trailer, semitrailer or truck camper is not in motion'

24 25 26 27 28 29 30 31 32 33	This amendment is the majority report of the committee. The amendment provides that the glove compartment of a motor vehicle is considered to be within the passenger area only if the glove compartment is unlocked. The amendment, in the wording on what constitutes a violation of the law, changes "places marijuana or a marijuana product" in a manufacturer's nonmarijuana container to "possesses marijuana or a marijuana product" in a manufacturer's nonmarijuana container. The amendment limits the exception for a passenger who possesses an open container or a passenger consumes marijuana or a marijuana product in the living quarters of a motor home, trailer, semitrailer or truck camper to a passenger who engages in that conduct while the motor home, trailer, semitrailer or truck camper is not in motion.
