**An Act To Add Instruction in Personal Finance to the Statewide  
System of Learning Results**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA §6209, first ¶**, as amended by PL 2015, c. 489, §3, is further  
3 amended to read:

4 The department in consultation with the state board shall establish and implement a  
5 comprehensive, statewide system of learning results, which may include a core of  
6 standards in English language arts and mathematics for kindergarten to grade 12  
7 established in common with the other states, as set forth in this section and in department  
8 rules implementing this section and other curricular requirements. The department must  
9 establish accountability standards at all grade levels in the areas of mathematics; reading;  
10 and science and technology. The department shall establish parameters for essential  
11 instruction in English language arts; mathematics; science and technology; social studies,  
12 including personal finance; career and education development; visual and performing  
13 arts; health, physical education and wellness; and world languages. Only a public school,  
14 a public charter school as defined in section 2401, subsection 9 or a private school  
15 approved for tuition purposes that enrolls at least 60% publicly funded students, as  
16 determined by the previous school year's October and April average enrollment, is  
17 required to participate in the system of learning results set forth in this section and in  
18 department rules implementing this section and other curricular requirements. The  
19 commissioner shall develop accommodation provisions for instances where course  
20 content conflicts with sincerely held religious beliefs and practices of a student's parent or  
21 guardian. The system must be adapted to accommodate children with disabilities as  
22 defined in section 7001, subsection 1-B.

23 **Sec. 2. 20-A MRSA §6209, sub-§2, ¶G**, as enacted by PL 1995, c. 649, §1, is  
24 amended to read:

25 G. Social studies, including personal finance; and

26 **Sec. 3. Rulemaking for personal finance standards.** By January 1, 2020, the  
27 Department of Education shall adopt rules to include personal finance standards in the  
28 statewide system of learning results, pursuant to the Maine Revised Statutes, Title 20-A,  
29 section 6209.

30 **SUMMARY**

31 This bill requires the Department of Education to add instruction in personal finance  
32 to the statewide system of learning results and to adopt rules accordingly.
