An Act To Provide a Source of Funding for the ATV Recreational Management Fund

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §13155, sub-§5**, as repealed and replaced by PL 2011, c. 116,
3 §1 and affected by §2, is amended to read:

4 **5. Fees.** The ATV registration fee is:

5 A. For a resident, ~~\$33~~ \$45 annually. The registration for an ATV owned by a
6 resident is valid for one year, beginning on July 1st of each year. Twelve dollars of
7 this fee must be deposited in the ATV Recreational Management Fund established in
8 section 1893, subsection 2; and

9 B. For a nonresident:

10 (1) ~~Fifty-three~~ Sixty-five dollars for a registration valid for 7 consecutive days.
11 A person may purchase more than one 7-day registration in any season. Twelve
12 dollars of this fee must be deposited in the ATV Recreational Management Fund
13 established in section 1893, subsection 2; and

14 (2) ~~Sixty-eight~~ Eighty dollars for a registration valid for one year. Twelve
15 dollars of this fee must be deposited in the ATV Recreational Management Fund
16 established in section 1893, subsection 2.

17 The registration for an ATV owned by a nonresident must specify the dates for which
18 the registration is valid.

19 **SUMMARY**

20 This bill increases ATV registration fees from \$33 to \$45 for annual registrations for
21 residents, from \$53 to \$65 for 7-day registrations for nonresidents and from \$68 to \$80
22 for one-year registrations for nonresidents. The bill provides that the increased fee
23 revenue be deposited in the ATV Recreational Management Fund.
