COMMITTEE AMENDMENT "A" to H.P. 224, L.D. 300, Bill, "An Act To Protect Hourly School Personnel Pay During School Days Missed Due to Weather or Emergency Closures"

Amend the bill by striking out the title and substituting the following:

**'An Act To Provide School Personnel Paid Hourly a Wage Pay Option'**

Amend the bill by inserting after the title and before the enacting clause the following:

**'Mandate preamble.** This measure requires one or more local units of government to expand or modify activities so as to necessitate additional expenditures from local revenues but does not provide funding for at least 90% of those expenditures. Pursuant to the Constitution of Maine, Article IX, Section 21, 2/3 of all of the members elected to each House have determined it necessary to enact this measure.'

Amend the bill by striking out all of section 2.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

**SUMMARY**

This amendment strikes the portion of the bill that requires a school administrative unit to pay school personnel who are paid on an hourly basis for the hours not worked when a school day is canceled or shortened due to circumstances beyond the control of school officials. The amendment also adds a mandate preamble.

### Fiscal Note

State Mandate - Exempted

#### State Mandates

Required Activity	Unit Affected	Local Cost
Requires school administrative units to provide school personnel who are paid on an hourly basis with the option of receiving pay over a period of 12 months or shorter.	School	Moderate statewide

Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional costs.
