12	Amend the resolve by striking out all of section 1 and inserting the following:
13 14 15 16 17	'Sec. 1. Adoption. Resolved: That final adoption of portions of Chapter 101: ConnectME Authority, a provisionally adopted major substantive rule of the ConnectME Authority that has been submitted to the Legislature for review pursuant to the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A, is authorized only if the following change is made:
18 19 20 ·	1. The rule must be amended in section 2, subsection A, in the definition of "advanced communications technology infrastructure" to clarify the conditions of the definition by stating the definition in outline form.
21 [·] 22	The ConnectME Authority is not required to hold hearings or undertake further proceedings prior to final adoption of the rule in accordance with this section.'
23 24	Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

26 27 28 29	This amendment allows for the final adoption of portions of Chapter 101: ConnectME Authority, a major substantive rule of the ConnectME Authority, as long as the ConnectME Authority amends the rule to clarify the definition of advanced communications technology infrastructure.
