### An Act To Make Election Day a State Holiday

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 4 MRSA §1051**, as repealed and replaced by PL 1985, c. 819, Pt. A, §1, is  
3 amended to read:

4 **§1051. Legal holidays**

5 ~~No court~~ Court may not be held on Sunday or any day designated for the annual  
6 Thanksgiving; New Year's Day, January 1st; Martin Luther King, Jr., Day, the 3rd  
7 Monday in January; Washington's Birthday, the 3rd Monday in February; Patriot's Day,  
8 the 3rd Monday in April; Memorial Day, the last Monday in May, but if the Federal  
9 Government designates May 30th as the date for observance of Memorial Day, the 30th  
10 of May; the 4th of July; Labor Day, the first Monday of September; Columbus Day, the  
11 2nd Monday in October; the day of the general election, as defined in Title 21-A, section  
12 1, subsection 19; Veterans' Day, November 11th; or ~~on~~ Christmas Day. The Chief Justice  
13 of the Supreme Judicial Court may order that court be held on a legal holiday when ~~he~~ the  
14 Chief Justice finds that the interests of justice and judicial economy in any particular case  
15 will be served. The public offices in county buildings may be closed to business on the  
16 holidays named in this section. When any one of the holidays named in this section falls  
17 on Sunday, the Monday following ~~shall~~ must be observed as a holiday, with all the  
18 privileges applying to any of the days named in this section.

19 **Sec. 2. 5 MRSA §59** is enacted to read:

20 **§59. General election day established as state holiday**

21 The day of the general election, as defined in Title 21-A, section 1, subsection 19, is a  
22 state holiday. All nonessential state offices must be closed on the day of the general  
23 election.

24 **Sec. 3. 9-B MRSA §145, sub-§1, ¶I-1** is enacted to read:

25 I-1. The day of the general election, as defined in Title 21-A, section 1, subsection  
26 19;

27 **Sec. 4. 20-A MRSA §4802, sub-§1, ¶E-1** is enacted to read:

28 E-1. The day of the general election, as defined in Title 21-A, section 1, subsection  
29 19;

30 **SUMMARY**

31 This bill designates the day of the general election, which is the day of the regular  
32 election of state and county officials occurring biennially in November, as a state holiday.
