16	matters no later than March 1, 2021. The joint standing committee is authorized to report						
17	out a bill based on the report to the First Regular Session of the 130th Legislature.

Fiscal Detail and Notes

The bill requires the Department of Professional and Financial Regulation, Bureau of Insurance, to review and evaluate the expansion of adult dental insurance coverage. The department has indicated it will require, and the bill includes in fiscal year 2020-21 only, an allocation of \$12,500 to contract out for this review. This allocation will be funded by existing resources within the Bureau of Insurance.
