**SUMMARY** 15 16 This amendment is the majority report of the Joint Standing Committee on Judiciary. 17 This amendment replaces the bill. The bill requires a probate court to appoint an attorney in all adult guardianship, conservatorship and other protective proceedings if the 18 adult is not already represented by an attorney. 19 20 This amendment establishes a presumption that every adult in a guardianship, conservatorship or other protective proceeding is entitled to legal representation when not 21 already represented and requires the court to appoint an attorney, except that the 22 23 presumption may be rebutted if the court finds by clear and convincing evidence that the adult knowingly and voluntarily refuses such representation and does not wish to contest 24 25 any aspect of the proceeding or powers of the guardian or conservator or limitation to the

26 protective arrangement.
