14	the coastal area may include in its comprehensive plan projections regarding changes in	-
15	sea level and potential effects of the rise in sea level on buildings, transportation	
16 17	infrastructure, sewage treatment facilities and other relevant municipal, multimunicipal or privately held infrastructure or property and may develop a coordinated plan for	-
17	addressing the effects of the rise in sea level. For the purposes of this subsection, "coasta	
19	area" has the same meaning as in Title 38, section 1802, subsection 1.	;
20	Amend the bill by relettering or renumbering any nonconsecutive Part letter or	•
21	section number to read consecutively.	
22	SUMMARY	
23	This amendment clarifies that a municipality or multimunicipal region that is in the	•
23	"coastal area" as that term is defined in the Maine Revised Statutes, Title 38, section	
25	1802, subsection 1 is subject to the bill. The amendment also strikes from the bill a	
26	requirement that state, local and certain federal agencies responsible for regulating	
27	planning, developing or managing coastal resources conduct their activities affecting the	
28	coastal area consistent with the policy of encouraging the assessment of and planning for	
29	the effects of the rise in sea level.

Any additional costs to the Department of Environmental Protection or the Department of Agriculture, Conservation and Forestry to encourage the assessment of and planning for the effects of a change in sea level on relevant state, regional, municipal or privately held infrastructure, property or resources are expected to be minor and can be absorbed within existing budgeted resources.

Municipalities may incur costs if they choose to rewrite existing comprehensive plans to incorporate the assessment of and planning for the effects of a change in sea level. Such rewrites would be voluntary and any related costs are not expected to be significant.
