1 2 3	J. A representative of a southern Maine planning and development commission, appointed by the Speaker of the House of Representatives upon the recommendation of the planning and development commission;
4 5	K. A representative of a Washington County council of governments, appointed by the President of the Senate upon the recommendation of the council;
6	L. The following 5 individuals, appointed by the President of the Senate:
7 8	(1) A representative of an organization that represents the interests of municipalities in the State;
9 10	(2) A representative of an organization that represents the interests of the tourism or recreational industry in the State;
11 12 13	(3) A representative of a statewide organization that promotes professional environmental management practices to protect and improve the waters and related environments in the State;
14 15	(4) A representative of an organization that represents the interests of a marine- based industry in the State; and
16 17	(5) A member of the public with demonstrated expertise in the matters to be addressed by the commission; and
18 19	M. The following 4 individuals, appointed by the Speaker of the House of <u>Representatives:</u>
20 21	(1) A representative of an organization that represents the interests of the real estate industry in the State;
22 23	(2) A representative of an organization that represents the interests of a working waterfront or fisheries-based industry in the State;
24 25	(3) A member of the public with demonstrated expertise and credentials in marine-based policy; and
26 27	(4) A member of the public with demonstrated expertise in the matters to be addressed by the commission.
28 29	3. Chairs. At the first meeting of the commission, the commission shall select a chair from among its members and may select a new chair annually.
30 31 32 33	4. Staffing. The Legislative Council shall provide staff support for the operation of the commission, except that Legislative Council staff support is not authorized when the Legislature is in regular or special session. In addition, the commission may contract for administrative, professional and clerical services if funding permits.
34 35 36	5. Quorum. For purposes of holding a meeting, a quorum is a simple majority of all members appointed to the commission under subsection 2. A quorum must be present to start a meeting or to vote but not to continue or adjourn a meeting.
37 38	6. Terms; vacancies. Members of the commission serve for a term of 2 years and may be reappointed. A vacancy must be filled in the same manner as the original

1 2	appointment. Members may continue to serve until their replacements are designated. A member may designate an alternate to serve on a temporary basis.
3 4	7. Consultation. Whenever the commission considers it appropriate, the commission may seek the advice of experts in fields related to its duties.
5	8. Powers and duties. The commission shall:
6 7 8	A. Meet at least 4 times annually. The Executive Director of the Legislative Council shall call the first meeting of the commission as soon as funding permits and all appointments have been made;

Review the best available science relating to current and future coastal and coastal watershed hazards, including, but not limited to, increased storm surges, extreme precipitation and other extreme weather events, projected sea level rise and increased river flooding and storm water runoff. The commission shall make available on a publicly accessible website all publications and information reviewed or compiled for review by the commission;
15 16 17 18	C. Identify coastal assets that are vulnerable to current and future coastal and coastal watershed hazards and determine the risks to be considered by the commission in developing a set of objectives and recommendations for action under paragraphs D and E;
19 20 21	D. Develop or identify a set of objectives, actionable strategies and best practices to protect, adapt and sustain coastal assets that are vulnerable to current and future coastal and coastal watershed hazards identified by the commission; and
22 23 24 25	E. Develop recommended legislation, rules and other actions in accordance with the set of objectives, strategies and best practices developed or identified under paragraph D to reduce the vulnerability of coastal assets and to adapt to current and future coastal and coastal watershed hazards identified by the commission.
26 27 28 29 30 31	9. Report and recommendations. On or before November 1, 2022, and every 4 years thereafter, the commission shall submit a report to the joint standing committee of the Legislature having jurisdiction over environmental and natural resources matters containing its recommendations, including draft legislation, regarding actions to be taken by the State to address and prepare for coastal and coastal watershed hazards identified by the commission.
32 33 34 35 36 37 38	10. Compensation. Legislative members of the commission are entitled to receive the legislative per diem, as defined in Title 3, section 2, and reimbursement for travel and other necessary expenses for their attendance at authorized meetings of the commission. Public members not otherwise compensated by their employers or other entities that they represent are entitled to receive reimbursement of necessary expenses and, upon a determination of financial hardship, a per diem equal to the legislative per diem for their attendance at authorized meetings of the commission.
39 40 41	<u>11. Outside funding.</u> The commission may seek outside funding to fund the cost of public hearings, conferences, workshops, other meetings and other activities of the commission. All contributions are subject to approval by the Legislative Council in

1 accordance with its policies. All funds accepted must be forwarded to the Executive 2 Director of the Legislative Council along with an accounting record that includes the 3 amount of funds, the date the funds were received, from whom the funds were received 4 and the purpose of and any limitation on the use of those funds. The executive director 5 shall administer any funds received by the commission and accepted as approved by the 6 Legislative Council.

SUMMARY

8 This bill establishes the Maine Coastal Risks and Hazards Commission, the purpose 9 of which is to develop and submit legislative recommendations regarding the actions to be taken by the State to address and prepare for coastal and coastal watershed hazards 10 identified by the commission, including, but not limited to, increased storm surges, 11 extreme precipitation and other extreme weather events, projected sea level rise and 12 increased river flooding and storm water runoff. On or before November 1, 2022, and 13 every 4 years thereafter, the commission must submit a report to the joint standing 14 committee of the Legislature having jurisdiction over environmental and natural 15 resources matters containing its recommendations, including any draft legislation, to 16 address and prepare for identified coastal and coastal watershed hazards. 17
