- 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and
- 3 **Whereas,** the health, safety and future success of children are greatly influenced by 4 the children's diet and nutrition beginning at a very young age; and
- 5 **Whereas,** many families in the State do not have the income or the means to access 6 adequate nutrition and a healthy diet; and
- 7 **Whereas,** many children who do not receive adequate nutrition at home receive 8 nutritious food at school through various school food service programs; and

9 Whereas, this legislation needs to take effect before the expiration of the 90-day 10 period in order for schoolchildren in the State to benefit from the federal child and adult 11 care food program for the 2019-2020 school year; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

16 **Be it enacted by the People of the State of Maine as follows:**

17 Sec. 1. 20-A MRSA §6602, sub-§1, ¶D is enacted to read:

18 D. A school administrative unit shall participate in the federal child and adult care food program established in 42 United States Code, Section 1766 as required under 19 this paragraph. The commissioner shall assist school administrative units subject to 20 the requirements of this paragraph in developing a plan to participate in the federal 21 child and adult care food program to serve at-risk students who attend after-school 22 programming and in obtaining federal, state and private funds to pay for this 23 program. Beginning with the 2019-2020 school year, a school administrative unit 24 with at least one public school in which at least 50% of students qualified for a free or 25 reduced-price lunch during the preceding school year shall participate in the federal 26 27 child and adult care food program in accordance with 42 United States Code, Section 1766 during the school year, subject to the provisions of this paragraph. 28

- Notwithstanding other provisions of this paragraph, a school administrative unit that
 is required to operate a federal child and adult care food program may choose not to
 operate such a program if it determines by a vote of the governing body of the school
 administrative unit after notice and a public hearing that operating such a program
 would be financially or logistically impracticable.
- 34 **Emergency clause.** In view of the emergency cited in the preamble, this 35 legislation takes effect when approved.

SUMMARY

This bill provides for the participation in the federal child and adult care food program to serve at-risk students who attend after-school programming by school administrative units that choose to operate the program and have at least one public school in which at least 50% of students qualified for a free or reduced-price lunch during the preceding school year.
