This amendment removes the emergency preamble and emergency clause. It reduces the number of Senate members from 4 to 2 and increases the number of House members from 3 to 5. It adds the Commissioner of Administrative and Financial Services, or the commissioner's designee, to the Background Check Consolidation Commission. It moves the report deadline from December 4, 2019 to December 20, 2019.

Legislative Cost/Study

### Legislative Cost/Study

The general operating expenses of this study are projected to be \$3,750 in fiscal year 2019-20. An estimated \$6,120 is available in each of fiscal years 2019-20 and 2020-21 in the Legislature's proposed budget for legislative studies as well as any balances from prior years for this purpose. Whether these amounts are sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature. The additional costs of providing staffing assistance to the study during the interim can be absorbed utilizing existing budgeted staff resources.

#### Fiscal Detail and Notes

Any additional costs to the departments whose commissioners or their designess are required to serve on the Background Check Consolidation Commission are assumed to be minor and can be absorbed within existing budgeted resources.
