12 13	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and	
14 15	Whereas, the annual compensation for City of Brewer High School District trustees begins in fiscal year 2019-20, which begins July 1, 2019; and	
16 17 18	Whereas, to conduct its official business in a financially responsible manner for the benefit of its residents, the City of Brewer must include all upcoming financial obligations in the budget prepared for fiscal year 2019-20; and	
19 20 21 22	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,	
23	Be it enacted by the People of the State of Maine as follows:	
24 25	Sec. 1. P&SL 1925, c. 4, §4, 2nd ¶, 5th sentence is repealed and the following enacted in its place:	
26 27 28	Beginning in fiscal year 2019-20, each trustee of the City of Brewer High School District receives equal compensation annually as determined by the council of the City of Brewer to be paid from the funds of the City of Brewer High School District.	
29 30	<b>Emergency clause.</b> In view of the emergency cited in the preamble, this legislation takes effect when approved.'	
31 32	Amend the bill by relettering section number to read consecutivel	or renumbering any nonconsecutive Part letter or y.

This amendment adds an emergency preamble and clause to allow this legislation to become effective prior to the start of the City of Brewer's fiscal year 2019-20. The amendment clarifies that each City of Brewer High School District trustee receives the same amount of compensation and removes the provision in the bill regarding additional compensation for the president, treasurer and clerk.
