An Act To Ensure a Seat on the Shellfish Advisory Council Is Held by a Person with a Background and Credentials in a Field of Marine Science

1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 12 MRSA §6038, sub-§1, as enacted by PL 2007, c. 606, Pt. A, §2, is amended to read: 3 1. Appointment; composition. The Shellfish Advisory Council, referred to in this 4 section as "the council" and established by Title 5, section 12004-I, subsection 57-G, 5 consists of 13 members who are appointed by the commissioner as follows: 6 A. Four members who are commercial shellfish license holders, at least 3 of whom 7 must be primarily soft-shell clam harvesters. In making the appointments under this 8 9 paragraph, the commissioner shall consider up to 6 recommendations from associations representing the interests of persons who harvest shellfish commercially; 10 B. Two members who are shellfish aquaculture lease holders. In making the 11 appointments under this paragraph, the commissioner shall consider up to 3 12 recommendations from associations representing the interests of persons who raise 13 shellfish under aquaculture leases: 14 15 C. One member who represents the interests of municipalities with wastewater treatment systems; 16 D. Two members who are licensed wholesale seafood dealers who have been issued 17 a shellfish sanitation certificate pursuant to section 6856, subsection 1. In making the 18 19 appointments under this paragraph, the commissioner shall consider up to 3 recommendations from associations representing the interests of persons who buy 20 and sell shellfish; 21 22 E. One public member with knowledge of and interest in coastal water quality; 23 F. Two members who are municipal shellfish wardens. In making the appointments under this paragraph, the commissioner shall solicit and consider up to 3 24 recommendations for these 2 appointments from associations representing the 25 interests of persons who protect and help manage municipal shellfish resources; and 26 27 G. One member who has been issued a shellfish depuration certificate under section 6856, subsection 3. 28 29 The commissioner shall make appointments so that the composition of the council reflects a geographic distribution along the coast of the State and so that at least one 30 member of the council has a demonstrated knowledge of a marine science and, at 31 minimum, a bachelor's degree in a field of marine science. 32 Sec. 2. Transition. Notwithstanding the Maine Revised Statutes, Title 12, section 33 6038, subsection 1, a member of the Shellfish Advisory Council as of the effective date 34 of this Act may serve the remainder of the member's term. 35
