14	§1551. Report regarding operating under the influence offenses
15 16 17 18 19 20 21 22	By April 1, 2020, and annually thereafter, the State Bureau of Identification shall report to the joint standing committee of the Legislature having jurisdiction over criminal justice matters regarding the incidence of operating under the influence offenses pursuant to Title 29-A, section 2411. The report must include separate categories for offenses involving operating under the influence of alcohol, for offenses involving operating under the influence of intoxicating substances other than alcohol and for offenses involving operating under the influence of a combination of alcohol and other intoxicating substances.'

24	This amendment replaces the bill. The amendment requires the Department of Public
25	Safety, State Bureau of Identification to report to the joint standing committee of the
26	Legislature having jurisdiction over criminal justice matters regarding the incidence of
27	operating under the influence offenses pursuant to the Maine Revised Statutes, Title
28	29-A, section 2411. The report must include separate categories for offenses involving
