3. Program approval. Each application for approval of a continuing education program must be submitted according to the guidelines prescribed by the board. The board may establish by rule criteria for the review and approval of courses and for the determination of the number of continuing education hours to be credited for completion of each course or program.'

SUMMARY

This amendment strikes and replaces the bill.

This amendment repeals the temporary licensure process for an individual with an 8 9 out-of-state license to practice funeral service. The amendment removes the term 10 "permanent" from the language describing the issuance of a license to an applicant with an out-of-state license and also removes a clause exempting such a license from annual 11 The amendment adds language stating that the license of the out-of-state 12 renewal. licensee must be active, unrestricted and without disciplinary action. The amendment 13 14 requires the State Board of Funeral Service to adopt rules to implement the section describing the issuance of a license to an out-of-state licensee, and specifically requires 15 that rules define what constitutes substantially similar license requirements. The 16 17 amendment also changes the continuing education requirements to allow for 6, rather 18 than 8 hours to be conducted remotely, and removes the requirement that all continuing 19 education programs be approved by the board.
