3 **Emergency clause.** In view of the emergency cited in the preamble, this 4 legislation takes effect when approved.'

SUMMARY

8 This amendment replaces the title and the bill and adds an emergency preamble and 9 emergency clause. It allows a person who holds a valid moose permit to transfer that 10 permit to an eligible disabled veteran. If a person does not identify a specific disabled 11 veteran to receive the transferred permit, the permit may be returned to the department, 12 which provides for the transfer of the permit to a disabled veteran.
