2	The Permanent Commission on the Status of Racial, Indigenous and Maine Tribal

5 6	Members of the commission are appointed for 2-year terms. A member may serve multiple terms.

The Governor, the President of the Senate and the Speaker of the House may terminate the membership of their respective appointees for good cause. The reason for the termination must be communicated in writing to a member whose membership is terminated. The membership of any member of the commission must be terminated if the member is absent from 3 consecutive meetings without communicating good cause to a chair of the commission.

22 SUMMARY

This amendment replaces the bill. It changes the name of the Permanent Commission on the Status of Racial and Ethnic Populations to the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal Populations and makes corresponding changes throughout the amendment to capture that change. It removes legislative members from the commission and makes additional changes to the public members of the commission. It further defines the duties and powers of the commission, including providing the commission with the authority to submit legislation at the start of each regular session. The amendment adds an appropriations and allocations section.

This bill includes Other Special Revenue Funds base allocations of \$500 per year beginning in fiscal year 2019-20 to a newly created Racial, Indigenous and Maine Tribal Populations dedicated account established within the Department of Labor to allow for the expenditure of any revenues received from public and private sources to support the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal Populations.

Additional costs to the Departments of Labor, Education, Health and Human Services and Economic and Community Development to provide input to the commission can be absorbed within existing budgeted resources.
