Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY 1 This amendment changes the fine structure proposed in the bill from a \$2,500 fine for 2 each subsequent violation of the various wage and hour laws to a fine of at least \$500 but 3 not more than \$2,500 for each subsequent violation. It also strikes new language added 4 by the bill regarding a civil action remedy for violations of various wage and hour laws. 5 It reduces the liquidated damages available in a civil action to collect unpaid minimum 6 wages from 3 times the amount of unpaid wages, as proposed by the bill, to twice the 7 amount of unpaid wages, and it reduces the Labor and Safety Inspector positions added to 8 9 the bill from 10 to 4.
