Whereas, as implementation of the federal Food Safety Modernization Act progresses, there is an increasing interest among growers of specialty crops in voluntary audit programs; and

Handling Practices" voluntary audit programs under the United States Department of

Agriculture, Agricultural Marketing Service; and

Whereas, these voluntary audit programs are among the best tools available to growers and distributors of specialty crops to ensure a base level of sanitation and food safety; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Establishment of a specialty crops certification cost-share pilot program. Resolved: That the Commissioner of Agriculture, Conservation and Forestry shall establish a specialty crops certification cost-share pilot program, referred to in this resolve as "the pilot program" for a period of 4 years. Under the program,

qualified farms may be entitled to reimbursement of up to 50% of the cost of certification of specialty crops under the "Good Agricultural Practices" and "Good Handling Practices" voluntary audit programs under the United States Department of Agriculture, Agricultural Marketing Service. "Specialty crops" means qualifying fruits and vegetables, tree nuts, dried fruits and horticulture and nursery crops, including floriculture;

Sec. 2. Reimbursement. Resolved: That reimbursement of funds under the pilot program is for initial one-time payment and may not be more than \$500 per qualified farm;

Sec. 3. Report. Resolved: That the Commissioner of Agriculture, Conservation and Forestry shall monitor the pilot program and report findings and recommendations to the joint standing committee having jurisdiction over agricultural matters no later than December 15, 2023. The joint standing committee having jurisdiction over agricultural matters may submit a bill to the Second Regular Session of the 131st Legislature relating to the subject matter of the report.

Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

SUMMARY

This amendment strikes and replaces the bill with a resolve and adds an emergency preamble and emergency clause. The amendment directs the Commissioner of Agriculture, Conservation and Forestry to establish a specialty crops certification cost-share pilot program in the Department of Agriculture, Conservation and Forestry and authorizes the department to reimburse qualified farms for up to 50% of the cost of certification of specialty crops under the "Good Agricultural Practices" and "Good Handling Practices" voluntary audit programs under the United States Department of Agriculture, Agricultural Marketing Service. The amendment provides that reimbursement of funds under the program is for initial one-time payment and may not be more than \$500 per qualified farm. The amendment also directs the commissioner to monitor the 4-year pilot program and to report back to the joint standing committee having jurisdiction over agricultural matters no later than December 15, 2023 with findings and recommendations.

Fiscal Detail and Notes

This resolve directs the Department of Agriculture, Conservation and Forestry (ACF) to establish a Speciality Crops Certification Cost-share pilot program beginning in fiscal year 2018-19 and ending in fiscal year 2022-23. The pilot program would provide an initial one-time reimbursement to qualified farms of up to \$500 for the cost of certification of specialty crops under the United States Department of Agriculture, Agricultural Marketing Service, "Good Agricultural Practices" and "Good Handling Practices" voluntary audit programs. ACF has indicated that limiting reimbursement to initial one-time payments will keep the cost of the pilot program within existing resources and no funding is included in the bill.
