28 29	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

31 32 33 34	This amendment, which is the unanimous report of the committee, replaces the bill. It changes the definition of "lead poisoning" in the Lead Poisoning Control Act to mean a confirmed elevated level of blood lead that is equal to or exceeds 5 micrograms per deciliter. It also requires the Department of Health and Human Services to report to the
