
**SUMMARY**

### Fiscal Detail and Notes

This amendment reduces General Fund appropriations by \$296,725 in fiscal year 2019-20 and increases General Fund appropriations by \$1,709,410 in fiscal year 2020-21. With this change to Committee Amendment "A", a balanced budget would still be maintained.
