19 20 21	Instruction in American history, government, citizenship and, Maine studies and the history of genocide must be aligned with the parameters for essential instruction and graduation requirements established under section 6209.

American history, government and citizenship, including the Constitution of the United States, the Declaration of Independence, the importance of voting and the privileges and responsibilities of citizenship, must be taught in and required for graduation from all elementary and secondary schools, both public and private.

Maine history, including the Constitution of Maine, Maine geography and environment and the natural, industrial and economic resources of Maine and Maine's cultural and ethnic heritage, must be taught. A required component of Maine studies is Maine Native American studies, which must be included in the review of content standards and performance indicators of the learning results conducted in accordance with section 6209, subsection 4. The Maine Native American studies must address the following topics:

Page 1 - 129LR2072(02)-1

A. Maine tribal governments and political systems and their relationship with local,

state, national and international governments;

- B. Maine Native American cultural systems and the experience of Maine tribal people throughout history;
- C. Maine Native American territories; and
- D. Maine Native American economic systems.
- 3. Genocide. The history of genocide, including the Holocaust, must be taught and must be included in the review of content standards and performance indicators of the system of learning results conducted in accordance with section 6209, subsection 4. For purposes of this subsection, "Holocaust" is the program of discriminatory and genocidal laws, policies or actions targeted against discrete groups of individuals based on race, religion, ethnicity, sexual orientation, physical disability or national origin, from January 1, 1933 to December 31, 1945, in Nazi Germany or in any European country allied with or occupied by Nazi Germany.
- Sec. 2. Appropriations and allocations. The following appropriations and allocations are made.

26 SUMMARY

This amendment replaces the bill. It requires that the history of genocide, including the Holocaust, to be taught in schools, aligned with the parameters for essential instruction and graduation requirements and included in the review of content standards and performance indicators of the system of learning results. It adds an appropriations and allocations section.

The fiscal note on this amendment identifies certain requirements in the amendment as a potential state mandate. In order to be a mandate pursuant to the Constitution of Maine, a provision must require a local unit of government to expand or modify its activities so as to necessitate additional expenditures from local revenue. The committee finds that the provision in the bill requiring the history of genocide to be taught in

The required local activities in this bill may represent a state mandate pursuant to the Constitution of Maine. If the bill does require a local unit of government to expand or modify its activities so as to necessitate additional expenditures from local revenue, the state mandate provisions of the Constitution of Maine require either: (1) General Fund appropriations be provided to fund at least 90% of any additional necessitated local costs of the mandate; or (2) a Mandate Preamble be added to the bill and two-thirds of the members of each House vote to exempt the mandate from the funding requirement. If the bill does represent a state mandate and neither one of these actions occurs, the local units of government will not be required to implement the mandated activities.

Fiscal Detail and Notes

This bill includes a one-time General Fund appropriation of \$9,000 in fiscal year 2019-20 to the Learning Systems program within the Department of Education for the costs associated with holding meetings with stakeholders to revise the social studies standards. The department has indicated that it has just completed a review of the social studies standards and, therefore, has not requested funding in the 2020-2021 biennial budget to conduct another review.
