9 COMMITTEE AMENDMENT "A" to H.P. 820, L.D. 1131, Bill, "An Act To 10 Improve the Ability of Senior Citizens and Persons with Disabilities To Stay in Their 11 Homes"

Amend the bill by striking out the title and substituting the following:

'Resolve, Directing the Maine State Housing Authority To Study and Report on the
Need for Modifications To Make Homes Accessible for Senior Citizens and Persons
with Disabilities'

Amend the bill by striking out everything after the title and inserting the following:

'Sec. 1. Maine State Housing Authority to study and report on need for 17 accessible housing. Resolved: That the Maine State Housing Authority shall work 18 19 together with local housing authorities and interested groups to conduct a study of the need, with reference to geographical areas of the State, for home modifications to provide 2021 accessibility for low-income older or disabled residents of the State in order to permit 22 those persons to remain in their homes and avoid institutionalization. The study must 23 evaluate the effectiveness of the income tax credit for certain home modifications. The 24 study must identify additional programs and funding and taxpayer assistance necessary to 25 meet the home modification needs of older and disabled individuals. The housing 26 authority shall report its findings to the Joint Standing Committee on Labor and Housing 27 and the Joint Standing Committee on Taxation by January 5, 2020. The joint standing 28 committees may each report out a bill based on the report to the Second Regular Session 29. of the 129th Legislature.'

30 Amend the bill by relettering or renumbering any nonconsecutive Part letter or 31 section number to read consecutively.

#### SUMMARY

This amendment changes the bill to a resolve and directs the Maine State Housing Authority to work with interested parties to study and make recommendations to the Second Regular Session of the 129th Legislature regarding the need, with reference to
