A cigar i deemed to have a characterizing flavor if the cigar is advertised or marketed a having or producing the taste or aroma of candy, chocolate, vanilla, fruit, berry, nut herb, spice, honey or an alcoholic drink, other than the taste or aroma of tobacco imparted either prior to or during consumption of a tobacco product or componen part thereof, including, but not limited to, tastes or aromas relating to any fruit chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb or spice however, a tobacco product may not be considered to have a characterizing flavor solely because of the use of additives or flavorings or the provision of ingredien information.'

#### Fiscal Detail and Notes

This amendment adds menthol, mint and wintergreen as tobacco product flavors prohibited by the bill. General Fund revenue will be reduced by \$3,324,725 in fiscal year 2019-20 and \$5,029,575 in fiscal year 2020-21. This revenue reduction is incremental to the revenue loss already in the committee amendment.
