COMMITTEE AMENDMENT "A" to H.P. 1008, L.D. 1394, "Resolve, To Direct the Department of Administrative and Financial Services To Conduct a Surplus Property Inventory"

Amend the resolve in the preamble in the 2nd paragraph in the last line (page 1, line 4 in L.D.) by striking out the following: "and" and inserting the following: 'now, therefore, be it'

Amend the resolve in the preamble by striking out all of the last paragraph (page 1, lines 5 and 6 in L.D.)

Amend the resolve in section 1 in the 7th line (page 1, line 13 in L.D.) by inserting after the following: "shall" the following: 'provide the inventory to and'

Amend the resolve in section 1 in the last line (page 1, line 17 in L.D.) by striking out the following: "by February 1, 2020." and inserting the following: 'and the Joint Standing Committee on State and Local Government by February 1, 2020. The Joint Standing Committee on State and Local Government may report out a bill to the Second Regular Session of the 129th Legislature related to surplus state-owned land and structures including a requirement that the department provide an annual report related to surplus state-owned land and structures.'

Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

**SUMMARY**

This amendment removes an inaccurate clause from the preamble. It adds a requirement that the Department of Administrative and Financial Services provide an inventory of surplus state-owned land and structures to the Maine State Housing Authority. The amendment also provides the Joint Standing Committee on State and Local Government with the option to introduce a bill in the Second Regular Session of the 129th Legislature related to the resolve.

### Fiscal Detail and Notes

This resolve directs the Department of Administrative and Financial Services (DAFS) to conduct an inventory of surplus state-owned land and structures and to work with the Maine State Housing Authority to determine the suitability of certain land and structures for development of affordable housing. Any additional costs to DAFS and the Maine State Housing Authority to implement the provisions of this bill are expected to be minor and can be absorbed within existing budgeted resources.
