25 26 27	2. Law enforcement officer. "Law enforcement officer" means a person who by virtue of public employment is vested by law with a duty to make arrests for crimes, whether that duty extends to all crimes or is limited to specific crimes.

29 30 31 32	Notwithstanding any provision of law to the contrary, a law enforcement agency may allow a law enforcement officer who is a veteran of the Armed Forces of the United States and who is employed by the agency to wear insignia on the officer's uniform to indicate that the officer is a veteran.'
