**An Act To Implement the Recommendations of the Right To Know
Advisory Committee Concerning Penalties for Violations of the
Freedom of Access Act**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 1 MRSA §410**, as repealed and replaced by PL 1987, c. 477, §6, is
3 repealed and the following enacted in its place:

4 **§410. Violations**

5 **1. Civil violation.** An officer or employee of a state government agency or local
6 government entity who willfully violates this subchapter commits a civil violation.

7 **2. Penalties.** A state government agency or local government entity whose officer or
8 employee commits a civil violation described in subsection 1 is subject to:

9 A. A fine of not more than \$500 for a civil violation described in subsection 1;

10 B. A fine of not more than \$1,000 for a civil violation described in subsection 1 that
11 was committed not more than 4 years after a previous adjudication of a civil violation
12 described in subsection 1 by an officer or employee of the same state government
13 agency or local government entity; or

14 C. A fine of not more than \$2,000 for a civil violation described in subsection 1 that
15 was committed not more than 4 years after 2 or more previous adjudications of a civil
16 violation described in subsection 1 by an officer or employee of the same state
17 government agency or local government entity.

18 **SUMMARY**

19 This bill replaces the existing penalty provision of the Freedom of Access Act to
20 establish a tiered schedule of fines for the civil violation of willfully violating the
21 Freedom of Access Act.

22 A state government agency or local government entity is subject to a fine of up to
23 \$500 for a first violation, a fine of up to \$1,000 for a 2nd violation and a fine of up to
24 \$2,000 for 3rd and subsequent violations committed within 4 years of an adjudication for
25 a willful violation. For the purposes of determining previous adjudications, a willful
26 violation can be committed by any employee of the agency or entity.
