14	Amend the bill in section 1 in §16002 by inserting after subsection 6 the following:						
15 16 17 18 19	' <u>The bundled rate must take into account the services identified in this section that are provided to an individual in the coordinated specialty care model in order to ensure fidelity to the model. In establishing the bundled rate, the department must consider various structures of a bundled rate model, including, but not limited to, a day rate or a monthly rate.</u>						
20 21	The department may review, develop or apply for any source of funds that may be available to implement reimbursement for the coordinated specialty care model.'

SUMMARY

This amendment, which is the unanimous report of the committee, clarifies that the department must establish a bundled rate for coordinated specialty care. It also provides that the department may review, develop or apply for any source of funds that may be available to implement reimbursement for the coordinated specialty care model. The amendment also adds an appropriations and allocations section.


