To provide, after reasonable notice to interested parties or their attorneys, for the transfer to the Treasurer of State for disposition as unclaimed property in the manner provided by Title 33, sections 1958 and 1959 chapter 45 of property in the possession or custody of the courts of this State as a result of civil or criminal litigation.

Except as otherwise provided in this section, on filing a report under section 2091, the holder shall pay or deliver to the administrator the property 7 8 described in the report. 9 **2.** Extension of date. If property in a report under section 2091 is an automatically 10 renewable deposit and a penalty or forfeiture in the payment of interest would result from paying the deposit to the administrator at the time of the report, the date for payment of 11 the property to the administrator is extended until a penalty or forfeiture no longer would 12 13 result from payment, if the holder informs the administrator of the extended date. 14 3. Delivery of tangible property in safe deposit box. Tangible property in a safe deposit box may not be delivered to the administrator until a mutually agreed upon date 15 no sooner than 120 days after filing the report under section 2091. 16 4. Security. If property reported to the administrator under section 2091 is a 17 18 security, the administrator may: 19 A. Make an endorsement, instruction or entitlement order on behalf of the apparent 20 owner to invoke the duty of the issuer, its transfer agent or the securities intermediary 21 to transfer the security; or B. Dispose of the security under section 2132. 22 23 5. Issuer of certificated security. If the holder of property reported to the administrator under section 2091 is the issuer of a certificated security, the administrator 24 25 may obtain a replacement certificate in physical or book-entry form under Title 11, 26 section 8-1405. An indemnity bond is not required. 27 6. Securities procedures. The administrator shall establish procedures for the registration, issuance, method of delivery, transfer and maintenance of securities 28 29 delivered to the administrator by a holder. 30 7. No liability after delivered. An issuer, holder and transfer agent or other person 31 acting in good faith under this section under instructions of and on behalf of the issuer or 32 holder is not liable to the apparent owner for, and must be indemnified by the State against, a claim arising with respect to property after the property has been delivered to 33 34 the administrator. 8. Nonfreely transferable security. A holder is not required to deliver to the 35 administrator a security identified by the holder as a nonfreely transferable security. If 36 37 the administrator or holder determines that a security is no longer a nonfreely transferable 38 security, the holder shall deliver the security on the next regular date prescribed for 39 delivery of securities under this Act. The holder shall make a determination annually

whether a security identified in a report filed under section 2091 as a nonfreely
 transferable security is no longer a nonfreely transferable security.

- 3 §2114. Effect of payment or delivery of property to administrator
- 1. No liability of holder on payment or delivery. On payment or delivery of property to the administrator under this Act, the administrator as agent for the State assumes custody and responsibility for safekeeping the property. A holder that pays or delivers property to the administrator in good faith and substantially complies with sections 2101 and 2102 is relieved of liability arising thereafter with respect to payment or delivery of the property to the administrator.
- 2. State indemnification. This State shall defend and indemnify a holder against
 liability on a claim against the holder resulting from the payment or delivery of property
 to the administrator made in good faith and after the holder substantially complied with
 sections 2101 and 2102.
- 14 §2115. Recovery of property by holder from administrator

 administrator may file a claim for reimbursement from the administrator of the amount

If a claim for reimbursement under 22 subsection 1 is made for a payment made on a negotiable instrument, including a traveler's check, money order or similar instrument, the holder must submit proof that the 23 instrument was presented and payment was made to a person the holder reasonably 24 25 believed entitled to payment. The holder may claim reimbursement even if the payment was made to a person whose claim was made after expiration of a period of limitation on 26 27 the owner's right to receive or recover property, whether specified by contract, statute or 28 court order.
- 3. Income or gain. If a holder is reimbursed by the administrator under subsection
 1, paragraph B, the holder may also recover from the administrator income or gain under
 section 2117 that would have been paid to the owner if the money had been claimed from
 the administrator by the owner to the extent the income or gain was paid by the holder to
 the owner.
- 34 <u>4. Property other than money, claim for return.</u> A holder that under this Act
 35 delivers property other than money to the administrator may file a claim for return of the
 36 property from the administrator if:
- 37 <u>A. The holder delivered the property in error; or</u>
- 38 B. The apparent owner has claimed the property from the holder.

- 5. Evidence property claimed. If a claim for return of property under subsection 4 is made, the holder shall include with the claim evidence sufficient to establish that the apparent owner has claimed the property from the holder or that the property was delivered by the holder to the administrator in error.
- 6. Affidavit sufficient. The administrator may determine that an affidavit submitted
 by a holder is evidence sufficient to establish that the holder is entitled to reimbursement
 or to recover property under this section.
- 8 7. No fee or other charge. A holder is not required to pay a fee or other charge for
 9 reimbursement or return of property under this section.
- 8. Determination on claim. Not later than 90 days after a claim is filed under
 subsection 1 or 4, the administrator shall allow or deny the claim and give the claimant
 notice of the decision in a record. If the administrator does not take action on a claim
 during the 90-day period, the claim is deemed denied.
- 14 9. Claim in Superior Court. A person aggrieved by a decision of the administrator
 15 may maintain an original action to establish the claim in the Superior Court of Kennebec
 16 County naming the administrator as a defendant.

17 §2116. Property removed from safe deposit box

Property removed from a safe deposit box and delivered under this Act to the administrator is subject to the holder's right to reimbursement for the cost of opening the box and a lien or contract providing reimbursement to the holder for unpaid rent charges for the box. The administrator shall reimburse the holder from the proceeds remaining after deducting the expense incurred by the administrator in selling the property.

23 §2117. Crediting income or gain to owner's account

- If property other than money is delivered to the administrator, the owner is entitled to receive from the administrator income or gain realized or accrued on the property before the property is sold. If the property was an interest-bearing savings or time deposit, the administrator shall pay interest at the current 10-year average cash pool rate. Interest is calculated from the date the property is delivered to the administrator and ends on the expiration of 10 years after its delivery or the date on which payment is made to the owner, whichever is earlier.
- 31 §2118. Administrator's options as to custody
- 32 <u>1. Custody declined.</u> The administrator may decline to take custody of property
 33 reported under section 2091 if the administrator determines that:
- A. The property has a value less than the estimated expenses of notice and sale of the
 property; or
- 36 <u>B. Taking custody of the property would be unlawful.</u>
- 37 2. Before presumed abandoned. A holder may pay or deliver property to the
 38 administrator before the property is presumed abandoned under this Act if the holder:

- 1 <u>A. Provides the apparent owner of the property notice required by section 2101 and</u> 2 provides the administrator evidence of the holder's compliance with this paragraph;
- B. Includes with the payment or delivery a report regarding the property conforming
 to section 2092; and
- 5 <u>C. First obtains the administrator's consent in a record to accept payment or delivery.</u>
 6 <u>The holder's request must be in writing.</u>
- 7 3. Presumed abandoned. On payment or delivery of property under subsection 2,
 8 the property is presumed abandoned.

9 §2119. Disposition of property having no substantial value; immunity from liability

- 10 **1. Return to holder.** If the administrator takes custody of property delivered under 11 this Act and later determines that the property has no substantial commercial value or that 12 the cost of disposing of the property will exceed the value of the property, the 13 administrator may return the property to the holder or destroy or otherwise dispose of the 14 property.
- **2. Immunity from liability.** An action or proceeding may not be commenced
 against the State, an agency of the State, the administrator, another officer, employee or
 agent of the State or a holder for or because of an act of the administrator under this
 section, except for intentional misconduct or malfeasance.

19 §2120. Periods of limitation and repose

- 1. Holder's duty to pay or deliver. Expiration, before, on or after October 1, 2019,
 of a period of limitation on an owner's right to receive or recover property, whether
 specified by contract, statute or court order, does not prevent the property from being
 presumed abandoned or affect the duty of a holder under this Act to file a report or pay or
 deliver property to the administrator.
- 25 **2. Proceeding within 10 years after report; tolled.** An action or proceeding may 26 not be maintained by the administrator to enforce this Act in regard to the reporting, 27 delivery or payment of property more than 10 years after the holder specifically identified 28 the property in a report filed with the administrator or gave express notice to the 29 administrator of a dispute regarding the property. In the absence of such a report or other 30 express notice, the period of limitation is tolled. The period of limitation is also tolled by 31 the filing of a report that is fraudulent.

SUBCHAPTER 7

- 33 SALE OF PROPERTY BY ADMINISTRATOR
- 34 §2131. Public sale of property

On another forum the administrator determines is likely to yield the highest net 10 proceeds of sale. 4. Highest bid insufficient. The administrator may decline the highest bid at a sale 11 under this section and reoffer the property for sale if the administrator determines the 12 13 highest bid is insufficient. 5. Publication of notice. If a sale held under this section is to be conducted other 14 than on the Internet, the administrator may publish at least one notice of the sale, at least 15 16 2 weeks but not more than 10 weeks before the sale. 17 §2132. Disposal of securities 18 1. Sell or liquidate security after one year. Except as provided in section 2155, subsection 1, the administrator may not sell or otherwise liquidate a security until one 19 year after the administrator receives the security. 20 2. Price of security. The administrator may not sell a security listed on an 21 22 established stock exchange for less than the price prevailing on the exchange at the time of sale. The administrator may sell a security not listed on an established exchange by 23 24 any commercially reasonable method. 25 §2133. Recovery of securities or value by owner 26 1. Claim for securities sold before one year after delivery. If securities are sold by the administrator before the expiration of one year after their delivery to the 27 administrator, a person making a claim under this Act before the end of the one-year 28 29 period is entitled to the proceeds of the sale of the securities or the market value of the securities at the time the claim is made, whichever is greater, plus dividends, interest and 30 other increments thereon up to the time the claim is made, less any deduction for 31 32 expenses of sale. A person making a claim under this Act after the expiration of the oneyear period is entitled to receive the securities delivered to the administrator by the 33 34 holder, if the securities remain in the custody of the administrator, or the net proceeds 35 received from sale and is not entitled to receive any appreciation in the value of the property occurring after delivery to the administrator, except in a case of intentional 36 37 misconduct or malfeasance by the administrator.

Claim for securities of a single issue. Notwithstanding this section, the
 administrator may sell the securities of any single issue for which custodial costs are
 likely to exceed value 90 days or more after the securities have been published pursuant
 to section 2103. A person making a claim under this Act after the securities have been
 sold is entitled only to the net proceeds received from the sale.

6 §2134. Purchaser owns property after sale

A purchaser of property at a sale conducted by the administrator under this Act takes
 the property free of all claims of the owner, a previous holder or a person claiming
 through the owner or holder. The administrator shall execute documents necessary to
 complete the transfer of ownership to the purchaser.

11 §2135. Military medal or decoration

<u>1. Sale prohibited.</u> The administrator may not sell a medal or decoration awarded
 for military service in the Armed Forces of the United States.

2. Delivery of medal or decoration. The administrator, with the consent of the respective organization under paragraph A, agency under paragraph B or entity under paragraph C, may deliver a medal or decoration described in subsection 1, to be held in custody for the owner, to:

- A. A military veterans' organization qualified under the federal Internal Revenue
 Code of 1986, 26 United States Code, Section 501(c)(19), as amended;
- 20 B. The agency that awarded the medal or decoration; or
- 21 <u>C. A governmental entity.</u>

3. Not responsible after delivery. On delivery under subsection 2, the
 administrator is not responsible for safekeeping the medal or decoration.

SUBCHAPTER 8

ADMINISTRATION OF PROPERTY

26 §2141. Deposit of funds by administrator

1. Unclaimed Property Fund. The administrator shall deposit in the Unclaimed
 Property Fund all funds received under this Act, including proceeds from the sale of
 property under subchapter 7. The Unclaimed Property Fund is a permanent account and
 may not lapse, but must be carried forward.

31 2. Payment of claims from Unclaimed Property Fund.  38 of another state if the administrator believes the property is subject to the custody of the

5. Retain an attorney. With the consent of the Attorney General, the administrator may retain an attorney in this State, another state or a foreign country to commence an action to recover property on behalf of the administrator and may agree to pay attorney's fees based in whole or in part on a fixed fee, hourly fee or a percentage of the amount or value of property recovered in the action.

6. Expenses. Expenses incurred by this State in an action under this section may be
 paid from property received under this Act or the net proceeds of the property. Expenses
 paid to recover property may not be deducted from the amount that is subject to a claim
 under this Act by the owner.

10 §2194. Interest and penalty for failure to act in timely manner

11 **1. Interest.** A holder that fails to report, pay or deliver property within the time 12 prescribed by this Act shall pay to the administrator interest at an annual rate of 18%, or 13 10% above the annual rate of discount in effect on the date the property should have been 14 paid or delivered for the most recent issue of 52-week United States Treasury bills, on the 15 property or value thereof from the date the property should have been reported, paid or 16 delivered.

Civil penalty. Except as otherwise provided in section 2195 or 2196, the

 under subsection 1, a civil penalty of \$200 for each day the duty is not performed, up to a

23 1. Evading obligation or willfully failing to perform. If a holder enters into a 24 contract or other arrangement for the purpose of evading an obligation under this Act or 25 otherwise willfully fails to perform a duty imposed on the holder under this Act, the administrator may require the holder to pay the administrator, in addition to interest as 26 27 provided in section 2194, subsection 1, a civil penalty of \$1,000 for each day the obligation is evaded or the duty is not performed, up to a cumulative maximum amount of 28 29 \$25,000, plus 25% of the amount or value of property that should have been but was not 30 reported, paid or delivered as a result of the evasion or failure to perform.

31 2. Fraudulent report. If a holder makes a fraudulent report under this Act, the 32 administrator may require the holder to pay to the administrator, in addition to interest 33 under section 2194, subsection 1, a civil penalty of \$1,000 for each day from the date the 34 report was made until corrected, up to a cumulative maximum of \$25,000, plus 25% of 35 the amount or value of any property that should have been reported but was not included 36 in the report or was underreported.

37 3. Lack of knowledge of death. A holder who fails to report, pay or deliver 38 property within the time prescribed by this Act is not required to pay interest under 39 section 2194, subsection 1 or subject to penalties under section 2194, subsection 2 if the 40 failure to report, pay or deliver the property was due to lack of knowledge of a death that 41 established the period of abandonment under this Act.

An agreement by an apparent owner and a professional investigator, as defined by Title 32, section 8103, subsection 5, the primary purpose of which is to locate, deliver, recover or assist in the location, delivery or recovery of property held by the administrator, is enforceable only if the agreement:

- 19 **2. Signed.** Is signed by or on behalf of the apparent owner; and

3. Amount or value. States the amount or known value of the property reasonably

 paid to the professional investigator has been deducted.

23 §2202. When agreement to locate property void

1. Agreement void in 24-month period. Subject to subsection 2, an agreement under section 2201 is void if it is entered into during the period beginning on the date the property was paid or delivered by a holder to the administrator and ending 24 months after the payment or delivery.

28 **2.** Mineral proceeds. If a provision in an agreement described in subsection 1 29 applies to mineral proceeds for which compensation is to be paid to the other person 30 based in whole or in part on a part of the underlying minerals or mineral proceeds not 31 then presumed abandoned, the provision is void regardless of when the agreement was 32 entered into.

33 3. Unconscionable amount; action to reduce amount. An agreement under
 34 subsection 1 that provides for compensation in an amount that is unconscionable is
 35 unenforceable except by the apparent owner. An apparent owner that believes the
