This amendment adds a provision to the bill to replace, in the Office of the Public Advocate, one Research Assistant position, salary range 30, with one Economic Analyst position, salary range 36, to align compensation with the assigned duties and qualifications of staff.

## Fiscal Detail and Notes

This bill increases the authorized number of employees of the Office of the Public Advocate (OPA) from 9 to 10 and replaces a Research Assistant position, range 30, with an Economic Analyst position, range 36. The OPA has indicated the additional position will allow the OPA to hire temporary staff and not utilize contracted services. Any costs from these provisions will be funded through assessments on utilities.
