- 1 Be it enacted by the People of the State of Maine as follows:
- 2 Sec. 1. 2 MRSA §9, sub-§6-A is enacted to read:

3 6-A. Renewable Energy Program. The Renewable Energy Program, referred to in this subsection as "the program," is established to promote the achievement of the 4 following goal: that, by January 1, 2050, 100% of the energy consumed in this State will 5 be supplied by renewable resources as defined in Title 35-A, section 3210, subsection 2, 6 paragraph C. The director shall work with the Public Utilities Commission, the 7 Efficiency Maine Trust Board established under Title 5, section 12004-G, subsection 8 9 10-C and the Department of Environmental Protection to develop and implement a plan to achieve the goal. By January 1, 2020 and annually thereafter, the director shall submit 10 a report to the joint standing committee of the Legislature having jurisdiction over energy 11 matters on the program and the progress toward the goal. 12

## 15 §1766-A. Electricity purchases

No later than January 1, 2010, all electricity consumed in state-owned buildings must 16 be supplied by renewable resources. No later than January 1, 2030, all electricity 17 purchased by state agencies must be supplied by renewable resources. No later than 18 19 January 1, 2050, all heating, ventilation and air conditioning systems in state-owned or state-leased buildings must be electrical and the electricity must be supplied by renewable 20 21 resources. For purposes of this section, "renewable resource" has the same meaning as in Title 35-A, section 3210, subsection 2, paragraph C. In purchasing electricity for state-22 owned buildings, the State may give preference to electricity generated by community-23 24 based renewable energy projects, as defined in Title 35-A, section 3602, subsection 1.

 following goal: that, by January 1, 2050, 100% of the energy consumed in this State will
 be supplied by renewable resources;

2. Directs that, no later than January 1, 2030, all electricity purchased by state agencies must be supplied by renewable resources and that, no later than January 1, 2050, all heating, ventilation and air conditioning systems in state-owned or state-leased buildings must be electrical and the electricity must be supplied by renewable resources; and 1 3. Directs that, no later than January 1, 2050, all vehicles acquired for the state 2 vehicle fleet must be electric vehicles.
